- Cross Border Payments (non-Euro):** international same day/next day value payments/two day value (non-Euro currencies).
- Receipts:** funds received into your account held with Barclays Bank Ireland PLC.
- Request for transfer:** an instruction sent by way of an MT101 message from Barclays.Net or to debit an account held with another bank. These requests may include cross border, SEPA or domestic payments to intercompany or third party beneficiaries.
